Lent begins on Ash Wednesday, March 6. As has been the case for the past several years, we will have two services on Ash Wednesday. There will be Holy Communion with the distribution of ashes at 12:00 noon and at 7:00 pm. I have said often in the past and will repeat it this year, there is nothing magical about receiving ashes on your forehead at the beginning of Lent. It is merely a symbol, a sign that you are entering into a season of renewal. That requires that you understand that you are in need of renewal from the inside out. It is not about doing things, not doing things, or omitting things from your consumption of things. It is, and has always been, about our relationship with the Lord.

The word Lent comes from a Latin word that means slow. The point of this is to back away from the distractions of the world so that everything in our life becomes more visible to us as it already is to God. The whole purpose of Lent is to allow us to see what God sees and then to allow him to do a spiritual diagnosis so that we can begin to fix what needs fixing or at least adjusting in our lives. The goal is to become more finely tuned to the will of God for us, to be led by His direction, and to submit ourselves wholly and completely to what God shows us. Anything we "do for Lent" has to be focused on that goal. Otherwise it is just some ritual we undertake for a period of time that simply waits for Easter to arrive. I'm not saying don't do these things. I'm saying that they must be done with a purpose in mind.

On Wednesday evenings during Lent I will celebrate Holy Communion at 7:00 pm. There will of course be some reflections on a topic pertinent to our spiritual journey. As soon as I know what the topic will be I'll let you know.

Confirmation Classes

Bishop Iker will be at St. Francis on June 23 for his annual visitation. At that time he will also confirm those I present to him. There will need to be instructions for Confirmation. These will begin on Tuesday, March 12, at 7:00 pm. I expect that there will be six to eight sessions each lasting about one hour or so. If you wish to be confirmed and have not yet informed me, I need to know now. I will have to have materials made up for the class. After the class begins there will be no further admittance.

Lenten Food Drive

In the past we have done a Lenten Food Drive for the benefit of The Storehouse. We donated our food to them for distribution because I liked their business model. It came not only with the distribution of food but with the dispensation of the Gospel. Unfortunately, as you know, The Storehouse is no longer in business, but people still need food. Therefore, this Lent we will be doing a food drive for the benefit of the food pantry at St. Louis Catholic Church on Burnet Road. They were practically our neighbors when we inhabited the office park over there. They also work with Mobile Loaves and Fishes, one of our ministry partners. More information will be given out soon about the needs. But I encourage you to participate if you are able.

Two other things. First of all, there will be the annual Pancake and Sausage Supper on Shrove Tuesday, March 5. Please watch for information in the Sunday pew sheet. Finally, 40 Days for Life will also run from Ash Wednesday to Palm Sunday. I am sure there will be additional information later in the newsletter.

ABORTION FOR FETAL ANOMALY:

THE COMPASSIONATE CHOICE FOR MOTHER AND BABY?

Note: Registered Nurse Lynn Smith presents an excellent overview on some key issues to consider when couples are counseled to abort their unborn child with a fetal disability. Although this article was written in the early 2000s, the Pain Capable Unborn Child Protection Act was last attempted to be passed into law in 2018.

In considering the H 4223, the Pain Capable Unborn Child Protection Act, people need to know that abortion is not a life saving, pain sparing medical procedure in the case of fetal disability.

There are 6,000-10,000 lethal fetal anomalies in the U.S. every year. Traditional treatment for lethal fetal anomalies is termination of pregnancy, and the reasons for such treatment are not necessarily based on sound medical rationale, but on emotion: obstetric providers' well intentioned desire to spare the mother and the family a distressing experience, their need to "do something," and their discomfort with bereaved patients. On the physiological level, a prudent doctor is motivated to avoid maternal complications of pregnancy and childbirth and fear of increased maternal mortality.

The doctors' desire to be in control and to prevent suffering is understandable. However, research reveals that termination does not necessarily prevent maternal complications, mortality, or suffering, but in fact, pregnancy termination increases the risk of physical harm and prolongs suffering. Grief after termination of a pregnancy is just as intense as after a spontaneous pregnancy loss; however, grief after termination for anomalies demonstrates prolonged consequences. A study in the Netherlands of women termination for anomalies psychological outcomes at monthly intervals. At four months, 46% of women had pathological levels of post-traumatic stress symptoms. At 16 months, 21% still had symptoms. Grief after termination is intense and persistent, as shown in another Netherlands study. Evaluated two to seven years post-termination, 2.6% had pathological grief, and 17% had post traumatic stress.

On the other hand, another study shows grief with first trimester spontaneous pregnancy loss is equal to that of live birth. In the first six months of the study, there was increased depression, anxiety and somatization with the loss group, but after one year there was no difference with the live birth group.

Dr. Calhoun notes that in comparing a 1994 study to the 1998 CDC report, maternal mortality for induced abortion at 16-20 weeks is about the same as for non-termination. However, the CDC itself acknowledges in its own reports that induced abortion morbidity and mortality are underreported. Therefore, it can be deduced that carrying a pregnancy to term is the safer choice.

A well-designed perinatal hospice program provides the kinder alternative of assisting the mother to carry her baby to term. This is kinder to the mother, in that she was not a proactive agent in the demise of her child, and kinder to the child, allowing it to live comfortably what time it has within the womb. A 2002 analysis found that 20% of patients will continue the pregnancy no matter what the diagnosis. Two studies show that 75%-85% of patients choose perinatal hospice when presented with the idea. The patients were all positive about hospice care and the opportunity to spend time with their infants, which, after delivery, lived from a few minutes to a few days.

Someone once said that you do not eliminate suffering by eliminating those who suffer. Abortion is not healthcare. Persons who have been involved in an abortion decision for any reason, if they are truly honest with themselves, know that abortion is cruel, ugly, and a desperate choice.

In so many circumstances in our society, from abortion to euthanasia to assisted suicide, we need to recognize that killing is not compassion. The word "compassion" comes from the words that mean "together" and "to suffer." Compassion is coming alongside those who suffer and living with them through their suffering. To suggest that death is the solution for life's problems is to abandon them to despair. Is there a soul to our society? How do we measure our humanity? The answer is by the degree to which we care for those humans who are suffering: the weak and vulnerable, the unwanted and imperfect, the dying.

FROM THE BISHOP

February 21, 2019

Following a Feb. 4 meeting of the Nominating Committee, members have begun organizing candidate visits and interviews, much as a search committee does when seeking a new rector. This will help the Committee determine a final slate of candidates, to be announced in Eastertide. Diocesan canons require at least three names to be placed in nomination. Biographical material and other information about each of the finalists will be published widely at that time. In addition, a process for submitting additional nominations by petition (also called 'nominations from the floor') will be announced.

On Saturday, May 11*, a Candidate Forum will be held at St. Andrew's, Fort Worth, for all clergy and their wives, and all lay delegates and alternates. These representatives, coming from each congregation, will have time to ask questions of each nominee. Afterward, audio and video recordings from the Forum will be made public online.

The Special Convention for the Election of a Bishop Coadjutor will be held Saturday, June 1*, at St. Vincent's Cathedral. The name of the Coadjutor-elect will be announced that day.

In accord with ACNA canons, the College of Bishops must examine and approve the Coadjutor-elect. This will occur during their regular meeting on June 14-15. The bishops are scheduled to gather at Christ Church in Plano, the same location where the first Archbishop was installed 10 years ago. Once the College of Bishops gives its consent, the Coadjutor-elect will be eligible for consecration.

God willing, the consecration service for the Bishop Coadjutor will take place Saturday, Sept. 21, the Feast of St. Matthew the Apostle, with Archbishop Foley Beach and me serving as chief consecrators. This service will include representatives from each congregation and numerous guests. The Bishop Coadjutor will begin making parish visitations on Sunday, Sept. 22.

My retirement celebration will take place at a banquet following the opening Eucharist of the 37th annual Diocesan Convention, on Friday, Nov. 15, in Granbury. Retired Archbishop Robert Duncan, who has been a friend of mine since seminary days, will be the keynote speaker after dinner. The regular Convention business meeting will be held Saturday, Nov. 16*.

I will continue to serve as chief pastor of the Diocese until my retirement on Dec. 31, 2019, when the Coadjutor will succeed me, becoming Fourth Bishop of Fort Worth on New Year's Day. His service of installation as Diocesan Bishop will be held Saturday, Jan. 4, 2020, at St. Vincent's Cathedral. At that time I will hand him the bishop's crosier, completing the transition of leadership.

With the Standing Committee, I extend my sincere thanks to the Nominating Committee for the work done so far and look forward to being updated on the committee's progress in the weeks ahead. Please continue to hold the members in your prayers and to pray for the guidance of the Holy Spirit as our next Bishop is chosen.
